



## **ANZSRS Advanced Education Grant Guidelines & Application**

### **Conditions**

- The ANZSRS Continuing Education grant is offered to encourage and support continuing education of respiratory clinical physiologist who have completed their core training and are intending to advance their skills and education in the more complex areas of pulmonary function testing.
- Only financial members of the ANZSRS who hold the CRFS credential are eligible to apply.
- Funding is for two grants each financial year to a total of AUD \$2,500 per grant to be used to help cover the cost of registration, travel and accommodation for attendance at the defined course/training.
- The Continuing Education grants will be awarded in January and July of each year that the grants are offered.
- It is required that grants will be used within a 12 month period from the date of the grant award.
- The continuing education/training must be linked to the applicants current role and provide for further training in the field of respiratory physiology and pulmonary function testing.
- At the conclusion of the study a Report and a Statement of Expenditure must be submitted to the ANZSRS Board.
- Successful applicants are required to present to their local team the value of the course and how what they learnt will both improve their own practice and the service offered.

### **Applications**

- Application closing date for first grant is last week of October.  
Application closing date for second grant is last week of April.
- All sections of the application must be completed within the sections provided using Arial font of no smaller than 10-point font size. No additional pages can be included in any applications.
- Applications are assessed by a review panel appointed by the Scientific & Conference Committee.
- Successful applications for the first grant will be announced by the end January.  
Successful applications for the second grant will be announced by the end July.

### **Application Submission**

Completed and signed copies of the application must be submitted by email to the ANZSRS Secretariat to arrive by the stated closing date.
