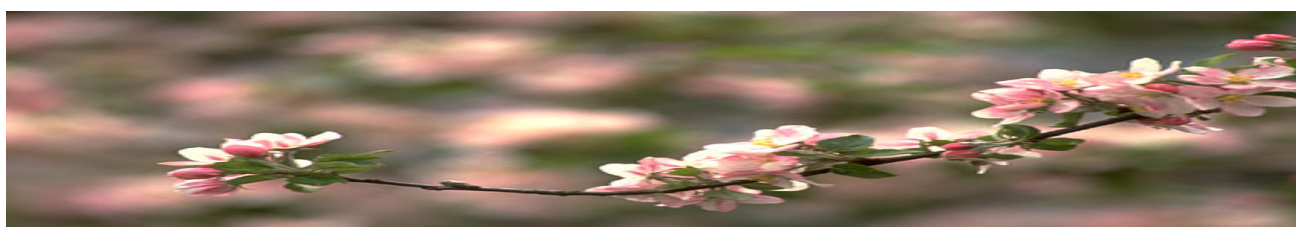


Library Corner August 2006
